NEW SEALED BID

FOREST GLEN HUNTS FOR 2020

The Vermilion County Conservation District will be auctioning six archery hunts. The hunting area is located in the central portion of the park and divided into two hunting zones. The auction will be ALL SEALED BIDS and you may choose between **Zone W** [previously the live auction zone] or **Zone E**, [previously the silent auction zone]. There will no longer be a live auction. **Zone W** is located on the **W**est side of Group Campground Road just past the gate. **Zone E** is located on the **E**ast side of the road just past the gate. The Earn-a-Buck program *does not apply* to these hunts but it is strongly encouraged that you harvest does. Hunters who win a week may bring ONE extra hunter with them to hunt in the same zone and the bid amount of the hunt will be doubled if the winning bidder chooses to bring an extra hunter.

The Sealed Bids will be opened first thing at the lottery drawing, Monday, July 20, 2020. Your bid must be postmarked by July 11, 2020; received by 4:30pm July 17, 2020. This year, due to COVID-19 concerns, neither the drawing nor the opening of the sealed bids will be open to the public. A video of the opening of the sealed bids and lottery drawing for hunt weeks will be available.

Winners will be contacted and must pay the bid in full by 4:30pm July 24.

All bidders will be notified by email or postal mail. In the event that a hunt week has no bids, that hunt week will be sold on a first-come, first-serve basis for \$1,000 starting August 3 at 8:30am. This will be advertised.
